Minutes of the meeting of the Rock County Soil and Water Conservation District Monday, November 20, 2023

A meeting of the Rock County Soil and Water Conservation District Board was held Monday, November 20, 2023at 8:00 AM at the Prairie Service Center with the following members present: Josh Ossefoort, Dave Esselink, Gene Cragoe, County Commissioner Stan Williamson, Director Eric Hartman, Assistant Director Doug Bos, Office Manager Mary Thompson, and Office Manager Shayla Rock. Absent: Roger Hoff and Jim Veldkamp

Vice Chair Ossefoort called the meeting to order and asked for any additions to the agenda. With no additions, motion to approve by Dave Esselink, second by Gene Cragoe. All ayes, no opposes, motion carried.

Grant Agreements:

Thompson presented the Buffer Law grant agreement explaining all signatures are electronic now so we are asking for signature authorization for Hartman. Motion to approve by Esselink, second by Cragoe. All ayes, no opposes, motion carried.

Thompson presented FY24/FY25 Soil and Water Conservation District Programs and Operations Grant Agreement. Thompson also explained that we will be receiving FY24 and FY25 this year due to a change in language by the legislation. They were able to amend to allow expiration of both year funds to 12/31/2025 rather than 6/30/25 so are sending both years at once to allow the 2 years to spend. Typically, the expiration date on the funds would be 12/31/2026. Motion to approve signature authorization to Eric Hartman by Cragoe, second by Esselink. All ayes, no oppose, motion carried.

Conservation Use Acre Contract Cancellation:

Thompson requested contract CUA-57 for Roger Wynia be cancelled as nothing was planted. Motion to approve by Esselink, second by Cragoe. All Ayes, no opposes, motion carried.

One Watershed One Plan Projects:

Bos stated the FY 24 funding is \$2 million. Tech group allocated 1.2 million for projects and \$800,000 for soil health. Some new incentives including stacking options of cover crop and strip till/no till on the same acres/\$10 per acre and \$20/per acre for stacked practices on the same acres for 3 years. Single species cover crop was increased to \$40 per acre and multi-species to \$60 per acre. Stacking options will be determined as to what is best for each farming operation.

Bos also stated there is potential for the SWCD to receive \$200,000 for soil health. Area V has potential for other grants for Decker's position, soil health field days and workshops.

Drill:

The board requested staff look into replacing the drill at the September meeting. Thompson stated for 2022 and 2023 combined drill income was \$10,082.10. Expenses for the drill for 2022 and 2023 were \$4,843.16, leaving a profit of \$5,238.94. Hartman stated ballpark for a new drill is estimated to be around \$45,000. Current drill that was purchased 7 years ago is estimated around \$32,000. Hartman will start looking at getting bids for new drill.

2024 Tree Prices:

Thompson presented tree price updates for 2024 along with adjusting the planting fee from \$135 to \$150. Motion to approve by Cragoe, second by Esselink. All Ayes, no opposes, motion carried.
