## Minutes of the meeting of the Rock County Soil and Water Conservation District Tuesday, February 22, 2022

A meeting of the Rock County Soil and Water District Board was held Tuesday, February 22, 2022 at 8:00 AM at the Prairie Service Center with the following members present: Gene Cragoe, Dave Esselink, Jim Veldkamp, Director Eric Hartman, Engineer Tech Arlyn Gehrke, Office Manager Mary Thompson. Absent: Josh Ossefoort, Roger Hoff, County Commissioner Stan Williamson

Acting Chair Esselink called the meeting to order and asked for any additions to the agenda. With no additions, motion to approve by Cragoe, second by Veldkamp. All ayes, no opposes, motion carried.

Arlyn Gehrke presented the Prescribed Grazing Plan for Jim Ladd which was developed by Patrick Toomey, NRCS. This grazing plan is in conjunction with the Wellhead Protection Partner Grant contract with Ladd's. Motion to accept plan by Veldkamp, second by Cragoe. All ayes, no opposes, motion carried.

Thompson presented payment for the Ladd for the 30-Year Wellhead Protection Partner Grant and requested the board authorize payment of \$950,238.00 once all signatures have been obtained. Motion to approve by Veldkamp, second by Cragoe. All ayes, no opposes, motion carried.

Thompson presented an overview of the 2021 Ag BMP program. \$619,510.00 in loans were approved and issued, current funds available are \$485,954.63 with \$210,000.00 allocated to projects in 2022.

Hartman presented the January financial statements. After review, motion to approve by Cragoe, second by Veldkamp. All ayes, no opposes, motion carried.

Hartman presented the 2020 audit. After review, motion to accept and approve by Veldkamp, second by Cragoe. All ayes, no opposes, motion carried.

Hartman gave an overview from the Area V meeting. Rock SWCD was presented with a plaque in recognition for 75 years of service. The association is working on increased funding sources. Local Capacity comes from the clean water fund and is re-approved every two years. SWCD's do not have taxing authority. It was attempted but not approved by the legislature or the governor. The association is working on annual funding from the general fund. The average would be \$170,000 and it would not be subject to ELINK reporting. Hartman stated these funds could possibly be used for a new drill and can be used for conservation practices.
