# Minutes of the meeting of the Rock County Soil and Water Conservation District Monday, July 18, 2022

A meeting of the Rock County Soil and Water District Board was held Monday, July 18, 2022 at 8:00 am at the Prairie Service Center with the following members present: Gene Cragoe, Dave Esselink, Jim Veldkamp, Roger Hoff, Josh Ossefoort, Director Eric Hartman, Assistant Director Doug Bos and Office Manager Mary Thompson. Absent: County Commissioner Stan Williamson

Chair Hoff called the meeting to order and asked for any additions to the agenda. With no additions, motion to approve by Ossefoort second by Veldkamp. All ayes, no opposes, motion carried.

# One Watershed One Plan Update

Thompson gave a project update stating there were 4 new project contracts approved in June. Three waterway contracts, one with two landowners, and a basin contract.

Bos presented a first round fund update and snapshot of the breakdown of funds spent. Total grant 1.3 million, project dollars 1.1 million, project development \$6,000, technical assistance \$55,000, administration to date \$77,000. There have been 59 waterway and 74 water and sediment control basins funded along with 151 field walkovers.

Bos gave an update on the 2022 funds stating the One Watershed One Plan Joint Powers board upon the recommendation of the Technical Committee has made revisions to the cost share policy with some changes to encourage non-structural conservation practices such as cover crops. Second round funds of 1.3 million have been received of which \$100,000 has been designated toward cover crops.

Cost share for cover crops provides funding toward seed and application with a maximum amount of \$10,000. The max for multi-species is approximately 80 acres at a rate of \$42.67 per acre for 3 years. The max for single species is approximately 96 acres at a rate of \$34.90 per acre for 3 years. Producers may also opt to apply for a comparison study grant through the MN Department of Ag in which the producer will work with an agronomist. Producer will receive \$1,000 per year and agronomist \$500 per year for 3 years.

The cost share policy on farmable terraces has been changed to the non-farmable rate to allow for more projects to be completed with the funding.

High priority concerns and issues (chosen by 1W1P board and committee, SWCD boards and the public) are:

- Elevated nitrates in drinking water
- · Sediment and phosphorus levels in streams and rivers
- Surface runoff vegetative cover and field residue
- Loss of functioning wetlands
- Loss of fish and wildlife habitat
- Land stewardship increasing soil health

#### **Conservation Use Acre Contracts**

The board approved the following conservation use acre contracts:

CUA-57 Wynia – 6 acres/600.00 in Mound Township, Section 1, NW ¼, waterway project. Motion to approve by Esselink, second by Ossefoort. All ayes, no opposes, motion carried.

CUA-58 VerSteeg – 5.5 acres/550.00 in Mound Township, Section 1, NE ¼, waterway project. Motion to approve by Veldkamp, second by Ossefoort. All ayes, no opposes, motion carried.
