SWCD Staff and Southwest Prairie TSA Staff will work with landowners that have requested assistance in complying with the Buffer Law through the alternative practices provision. The alternative riparian water quality structural conservation practice will be based on the Natural Resources Conservation Service Field Office Technical Guide.</p> <p>Assistance will include: site assessment, review of alternative practices, flagging, site inspection for compliance, enforcement for non-compliance following procedures defined within the buffer ordinance. Administration will include reporting in BuffCat and ELINK, updates to the SWCD board and any required board approval and signature.</p> <p>Staff will attend any training/meetings for any updates.</p>
